General Comments: This record review of the 2012 Annual Compliance Certification, DEP form 7007CC, serves to verify the report's receipt by the DAQ. The submittal appears to meet the reporting requirements found in the facility's permit and in Title 401 KAR 52:020 Section 21. No site visit or full compliance evaluation was conducted as part of this review.

EKU is required to monitor several different parameters for the boilers including the baghouse pressure drop, visible emissions, and the amount of coal used.

Any excursions shall be reported in the DEP7007CC.

Comment: Pursuant to 401 KAR 52:020, Permits, Section 21, the permittee shall annually certify compliance with the terms and conditions contained in this permit, by completing and returning a Compliance Certification Form (DEP 7007CC) (or an alternative approved by the regional office) to the Regional Office listed on the front of this permit and the U.S. EPA in accordance with the following requirements:

- a. Identification of the term or condition;
- b. Compliance status of each term or condition of the permit;
- c. Whether compliance was continuous or intermittent;
- d. The method used for determining the compliance status for the source, currently and over the reporting period.
- e. For an emissions unit that was still under construction or which has not commenced operation at the end of the 12-month period covered by the annual compliance certification, the permittee shall indicate that the unit is under construction and that compliance with any applicable requirements will be demonstrated within the timeframes specified in the permit.
- f. The certification shall be postmarked by January 30th of each year.

using Form DEP7007CC: All sources, including those that have not received a Title V permit, shall submit their	
certification each year on or before January 30. Compliance certifications shall be mailed to the Division for Air

floor, Frankfort, Kentucky 40601, and a copy sent to the U.S. EPA. [401 KAR 52:020 Section 21(1)(b)]
